## 1. Independent Vendor Status

If applicable (e.g., for bartending or food service), Vendor will also carry all necessary permits and specialty liability insurance.

#### 3. Code of Conduct & Venue Policies

Vendor agrees to:

- Arrive and depart within the venue's access windows or pre-approved times
- Follow all venue rules, including those related to alcohol, fire safety, music/noise levels, and décor restrictions
- Clean up their work area thoroughly
- Maintain professional and courteous behavior at all times
- Avoid sub-contracting services without venue approval

### 4. Marketing & Photography Usage

Vendor grants permission to The Barns at Crest Hill to use event photography or videography that includes their work (e.g., floral installations, catering setups, rental items, etc.) for marketing purposes.

In return, Vendor agrees that when publicly promoting services performed at The Barns at Crest Hill, they will:

• Credit the venue appropriately

• Include a **do-follow backlink** to https://thebarnsatcresthill.com when posting online (e.g., website, blog, social media)

### 5. Indemnification & Liability

Vendor agrees to indemnify and hold harmless Mati Properties, LLC, its owners, employees, and representatives from and against any and all claims, damages, injuries, or losses (including attorney's fees) arising out of:

- The actions or negligence of the Vendor or their staff while on venue property
- Any damage to persons or property caused by Vendor's services or equipment
- Any breach of this Agreement or failure to follow venue rules

This clause survives termination of this Agreement.

#### 6. Term & Revocation

This Agreement shall remain in effect unless revoked in writing by either party. The Barns at Crest Hill may revoke preferred vendor status at its sole discretion, particularly in cases of:

- Unprofessional behavior
- Lack of proper insurance or licensing
- Failure to follow venue policies
- Guest or client complaints
